<b>PURPOSE OF DATA PROCESSING:</b>	To fulfil, contractual and other legal obligations and to accomplish financial reporting obligation towards the Education, Audiovisual and Culture Executive Agency (hereinafter: EACEA) & H2020/REA (hereinafter: REA); to maintain a dissemination base for newsletters, info-points and invitations for future events.
<b>LEGAL BASIS OF DATA PROCESSING:</b>	Applicable European Union regulation on financial reporting towards EACEA (managing the ERASMUS+ Programme) & REA; Within the legal framework provided by the GDPR.
<b>ADRESSEES OF PERSONAL DATA:</b>	Consent of the data subject Employees and managers of the THA, SEERC, EACEA, REA (in addition, data might be transferred to responsible Agency departments or to the parties, such as the European Commission, Programme committee and European Parliament, National Contact Points as well as members of the public.
<b>TERM OF DATA RETENTION:</b>	Data retention will last for five years.

The personal data may be transferred for data processing (delivery) to EACEA Education, Audiovisual and Culture Executive Agency, REA and in addition, to responsible Agency departments or to the parties, such as the European Commission (e.g. DG Budget, DG Delegations, Research Executive Agency), Programme committee and European Parliament, National Contact Points as well as members of the public.

In case of control or dispute the bodies charged with a monitoring or inspection task in application of Union law (e.g. Internal Audit Service, Internal Audit Capacity, European Commission, OLAF, EU Courts etc.).

No personal data is shared with third parties.

#### **INFORMATION ON DATA SUBJECT'S RIGHTS:**

You have the right to request the data controller to access, to correct, to erase or to limit the processing of your personal data, you have the right to object the processing of such personal data, and you have the right to data portability. You have the right to revoke your consent, which does not affect the legality of data handling performed on the basis of consent of the data subject, before the revocation of the consent.

You have the right to file a complaint to the supervisory authority (Italian Data Protection Authority, in Italian: Garante per la protezione dei dati personali). Providing your personal data is not a condition of entering into a contractual relationship, you are not obliged to provide us your personal data, however if you do not provide us your personal data, it could make difficult to stay in touch.
